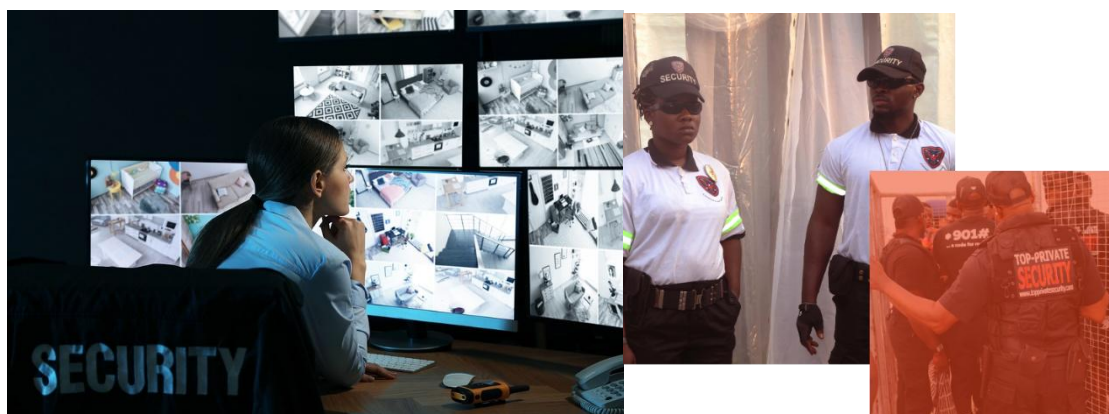

- b) All technical and supporting staff report to their respective immediate supervisors;

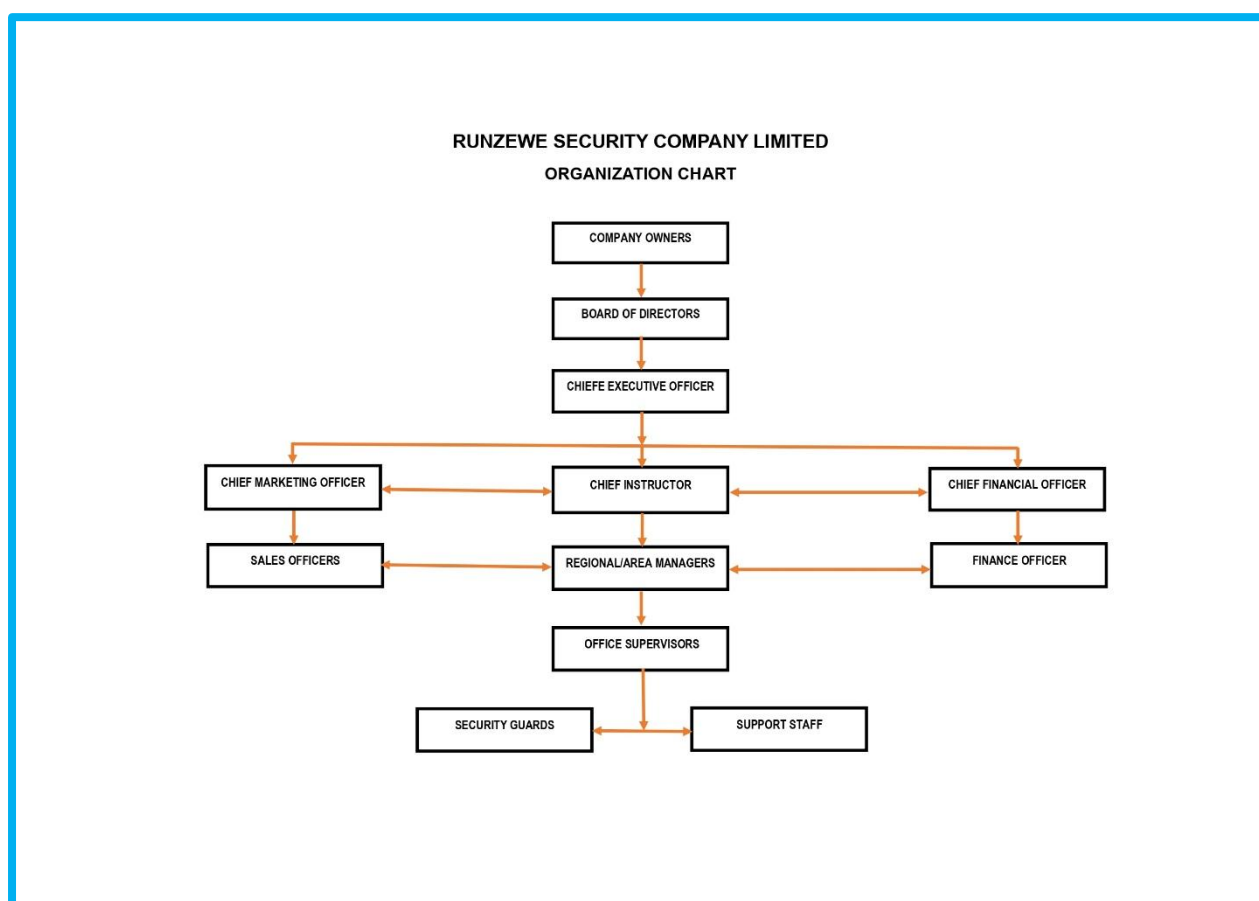
3.5 Security Guards

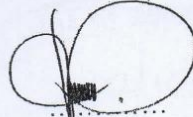

13. Askari wakaguliwe wanapoingia kazini, wanapokuwa kwenye malindo, na wanapotoka kazini.
14. Kampuni inapaswa kuwa na akaunti ya benki.

15. Kibali hiki kitakoma uhalali wake endapo utakiuka masharti yake na sheria, kanuni na taratibu zingine za nchi.

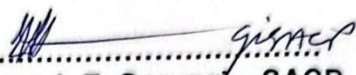
